#### NOMINATION PROCEDURE

- 4. Prospective candidates have to obtain nomination forms personally/ his Rep with Authority letter from GM (Adm) on payment of Rs. 50/- per form.
  - (a) Only those Members whose names appear in the Voter List are entitled to contest, propose or second names of contestants; our letter No. AVRWA/1-25/All Wards/131/Election 23-24 dt 09 Nov 23 & AVRWA/1-25 All Wards/131/Election 24-25 dt 26 Dec 2023 also refers.
  - (b) In nomination form, all entries will be correctly filled. Mutilated, defaced, too many cuttings/overwriting, which will make the form illegible or not readable may invite rejection. All cuttings should be authenticated by full signature of all concerned. Over writing will invite rejection of the form.
  - (c) The form will be sealed in the envelope, which should have details of person contesting for the Post, Membership No., Name, Address and date of submission. Ack should be obtained from General Manager (Adm).
  - (d) Nomination papers will be opened in the presence of Election Officer.

- 7. (i) On the day of Polling NO canvassing will be permitted within the AVCC premises. Violation of this norm may invite disqualification of contestant. Members are also requested to refrain from malicious campaigning. Escorting of voters to the polling booth is prohibited. A wheel chair will be available for voters whosoever needs it.
  - (ii) Videography for entire Election process will be carried out.
- 8. New members enrolled beyond (30/12/23), the dates as given in our letter No. AVRWA/1-25/All Wards/131/Election 23-24 dt 09 Nov 23 & AVRWA/1-25 All Wards/ 131 /Election 24-25 dt 26 Dec 2023 also refers will not be eligible to vote.
- 9. Voters list, duly amended shall be available on payment of Rs.200.00 for Chairman/Vice Chairman & Rs.20/- (Ward Directors) with effect from 03 Jan 2024 from Gen Manager (Adm) AVRWA.
- 10. Advisory Committee shall be constituted by the Election Officer to consider appeals representation etc, if any.
- 11. Name of one polling agent (if considered necessary by the contestant) may be given in writing to GM (Adm) by the contestants by **18 Jan 2024.**
- 12. Briefing of the contestants, their polling agents, polling officers and staff will be held by the Election officer at AVRWA on 22 Jan 2024 as per **Appendix-A**.
- 13. For the purpose of casting vote, possession of any of the national Identity Card, Aadhaar Card, will be essential.
